

My Elder Abuse journey began

January 1996

Even though California had an elder abuse law in existence since 1986

Penal Code section 368

Who are our victims under the code?

Elders & dependent adults

Elder = 65+

Dependent adult = 18 to 64 with mental or physical limitations

PC 368

- Physical abuse, mental abuse or neglect
- Financial abuse by non caregiver
- Financial abuse by caregiver
- False imprisonment

PC 368 continued

 Have to prove that Defendant knew or reasonably should have known that victim was an elder or dependent adult

In Virginia...

Nothing in Virginia Code except...

Incapacitated adults

Incapacitated adult" means any person 18 years of age or older who is impaired by reason of mental illness, intellectual disability, physical illness or disability, advanced age or other causes to the extent the adult lacks sufficient understanding or capacity to make, communicate or carry out reasonable decisions concerning his wellbeing. Va. Code Ann. § 18.2-369

Virginia does not have an age based criminal code definition for a victim of elder abuse

§ 22-932. Definitions.

For the purposes of this chapter, the term:

- (1) "Attorney General" means the Attorney General for the District of Columbia.
- (2) "Court" means the Superior Court of the District of Columbia.
- (3) "Elderly person" means a person who is 65 years of age or older.
- (4) "United States Attorney" means the United States Attorney for the District of Columbia.
- (5) "Vulnerable adult" means a person who is 18 years of age or older and has one or more physical or mental limitations that substantially impair the person's ability to independently provide for his or her daily needs or safeguard his or her person, property, or legal interests.





The aging of America

People are living longer. Birth rates are declining. By 2040, nearly one in every five Virginian will be older than 65.









Every year the Demographics Research Group is asked to give presentations on Virginia's demographic trends, and this year, as is true every year, the demographic trends we explored depended on our audience's area of interest —school enrollment change for the Board of Education, population growth trends for the House Appropriations Committee, or population projections for the Virginia Planning Association. However, behind all of these trends, there was one significant driving factor: aging. The aging of Baby Boomers is not only swelling the 65+ population, but is also having a ripple effect across all age groups, slowing growth in the working-age population and often causing decline in the school-age population.

The growth in Virginia's population over age 65 is a widely known trend and is commonly recognized as the most significant demographic change currently taking place across the U.S. But the expected rate of growth in the 65+ population is still stunning. In just 20 years (between 2010 and 2030), Virginia's population age 65 and older is expected to jump from 976,937 to 1,803,404, contributing to the majority of Virginia's population growth during the period. Outside of Northern Virginia, 85 percent of the projected population growth is predicted to come from those 65 and older. Benjamin Franklin famously said "in this world nothing can be said to be certain, except death and taxes." Barring a catastrophic spike in deaths, the aging of Virginia's population is also a certainty.

UNDERSTANDING THE DYNAMICS


- Fears of many seniors

For the first 7 months I did not prosecute any elder abuse case; instead I went around our county talking with law enforcement....

What did learn?

All victims deserve our utmost response



 Sadly, some victims are overlooked, ignored, disbelieved, or simply are abandoned I discovered that law enforcement through no fault of their own - were falling into common misconceptions... I have learned that to bring elder abuse out of the shadows, we need to recognize what is standing in our way...

Myth #1

Elderly people make terrible witnesses

Most common answer... forgetfulness

AVOID STEREOTYPING OF SENIORS

- Forgetful
- Senile
- Longwinded
- Grumpy
- Disabled
- Fragile



Myth #2

 If elderly victim refuses to provide information, there is nothing that can be done

- We can still build a case by talking to other key witnesses
- Start on the outside and work your way to the middle
- Let the DA figure out a way to break through victim's wall of silence

LESSONS LEARNED FROM DOMESTIC VIOLENCE

•Self -determination is not the answer

"Victim declines prosecution"

Hendersonville police officers always respond to calls, treating potential victims with compassion and dignity, Chief Herbert Blake said.

"We, the police, charge when the charges are there to be made and (if) we have a willing victim," he said.

the victim either knew the offender or was taken advantage of by "cheating someone the old-fashioned way," said Sheriff David Mahoney. These cases often include obtaining property by false pretense, or credit card or ATM fraud.

Out of those 26 cases, suspects were arrested in 12. In three cases, the victim did not press charges, five were determined to be unfounded, and six remain under investigation, Mahoney said.

Victims' fear of reprisals, dependence on their abusers for their daily care, and reluctance to send a loved one to prison make elder-abuse crimes notoriously difficult to prosecute, authorities say.

Why self-determination is a problem

- If not punished, the perp WILL abuse again
- We CAN convict even without the assistance of the victim
- Abuse is a crime against NOT JUST the abused

Profile of the physical abuser:

- Son in his late 30's to late 50's
- Living at home with Mom
- Divorced/ returns or single and unmotivated or just out of jail
- Lazy and unemployed
- Drugs, alcohol or gambling
- Feeds habit off Mom
- Sometimes history of mental illness

Sadly, I have learned much about elder abuse from prosecuting 10+ homicides over the past 22 years

Myth #3

•If elderly victim gives the money voluntarily, it is not a crime

The "it's a civil matter" mindset is pervasive

But things are not always how they first appear

There are times when the apparent voluntariness has been diluted by fraud, undue influence or by exploiting the mental limitations of the victim

Myth #4

 A Power of Attorney does not provide a license to steal and plunder

A family member who is the suspect - accelerated inheritance is not a good defense!

Myth #5

 If victim is deceased before we discover the theft, we cannot prosecute
